


WINDSOR LAKES

January/February 2019 Newsletter

During the time since our last note, the Board has completed 2019 budget planning and briefed it to interested community members. The sinkhole at the southwest corner of intersection of Haversham Court and South Dylanshire Circle was repaired and resodded. Work in the Edinburgh Court easement (East Forest Sanitary Sewer) has moved closer to completion.

The budget, particularly funds estimated for home monitoring, has gained considerable attention. This budget includes maintenance for iron fences installed by the builder when homes in Windsor Lakes were first sold. The Board included part-time personnel costs in our 2019 budget; an oversight had omitted it from the 2018 budget. We ensured



Funds set aside in our reserve fund to replace townhouse roofs are a significant part of the total reserve fund. As a part of the formulation of the 2019 budget, the Board chartered a study of projected townhouse roofing costs to determine if there will be enough funds in the reserve fund during 2021 through 2024 when the roofs are replaced. To everyone's pleasant surprise, the estimate produced by the study matched the amount being set aside in townhouse assessments. We appear to be on track to replace the townhouse roofs without an increase in assessments, but future changes in inflation and oil prices could change this picture.

An item generating considerable discussion has been the Board's decision to end paying the home alarm system monitoring fee after 2019. Of the 572 homes in Windsor Lakes less than 200 are using the builder installed system. That system has become obsolete. Red Hawk service has become expensive and unreliable. Our monitoring vendor, Red Hawk is moving out of the home monitoring business and wants to raise their prices for monitoring and service.

In order for the residents of Windsor Lakes to be informed of the wide range of options that are now available for providing home security the Board will arrange for a Home Security Forum In Windsor Lakes in early 2019.
